Further, it is stated that folios wherein any one of the cited document / details are not furnished or made available <u>on or</u> <u>after April 01, 2023</u>, the relevant folio(s) shall be frozen by the Registrars and Transfer Agent of the Company (RTA).

## Effective January 1, 2022, shareholders will not be eligible to lodge their grievance or avail service request from the RTA unless PAN, KYC and Nomination documents/details are received.

All shareholders who have not furnished the documents/details viz., PAN, E-mail address, mobile number, bank account and nomination are requested to send the documents given below:

- Confirmation of signatures of securities holder by the banker should be furnished in Form No. ISR 2 (<u>Click here for Form No. ISR 2</u>);
- Declaration form for Opting-out of Nomination should be furnished in Form No. ISR 3 (<u>Click here for Form No. ISR 3</u>);
- Request for issue of Duplicate share certificate and other service requests should be furnished in Form No. ISR 4 (<u>Click here for Form No. ISR 4</u>);
- Nomination details should be furnished in Form SH-13 (<u>Click here for Nomination</u> related forms)
